**ORDER RE:
CONSOLIDATION AND APPOINTMENT OF LEAD PLAINTIFF**

In this securities class action brought by shareholders of Egalet Corporation, movants Johseph Spizzirri, Abdul Rahiman, and Kyle Kobold (collectively, the “Eaglet Investor Group”) filed a Motion for Consolidation, Appointment as Lead Plaintiff, and Approval of Selection of Counsel (ECF 11) on March 28, 2017. In its motion, Egalet Investor Group requests that the above-captioned case be consolidated with *Klein v. Egalet Corporation et. al*, (2:17-cv-00617-MMB) which is also pending before this court. Further, Egalet Investor Group requests to be appointed as lead plaintiff, and for the court to approve of its selection of counsel.

Defendants filed a response to the Egalet Investor Group’s Motion on April 11, 2017 (ECF 16). In their response, Defendants agreed that the cases should be consolidated. Defendants also noted that they lack standing to object to the appointment of movants as lead plaintiff, and therefore took no position on this matter. Defendants reserved their rights to later object to the adequacy and typicality of the lead plaintiff at the class certification stage.

Initially, there had been a competing Motion to be appointed as lead plaintiff (ECF 10) pending in this case. However, the competing motion was withdrawn, and the filers of that Motion indicated their support for the appointment of the Egalet Investor Group as lead Plaintiff. (ECF 15).

Accordingly, Egalet Investor Group's Motion (ECF 11) is **GRANTED**. This case shall be consolidated with *Klein v. Egalet Corporation et. al*, (2:17-cv-00617-MMB). The Court Appoints Egalet Investor Group as Lead Plaintiff, and approves of their selection of the Law firms Levi & Korsinsky LLP and Pomerantz LLP as Co-Lead Counsel, and their selection of O'Kelly & Ernst, LLC as Liaison Counsel.
